My research interests center on expressions of antisocial and prosocial behavior. Specifically, I am interested in the individual differences (e.g., racism, social vigilantism, masculine honor beliefs, beliefs in pure good and pure evil) and situational factors that contribute to the justification and suppression of antisocial behavior (e.g., prejudice, aggression), as well as to decisions to behave prosocially (e.g., to give or withhold help).
