Brief (1 paragraph) summary of professional interests:

My research uses a social-cognitive approach to understand a variety of phenomena. In recent years, I have used this approach to understand the relations among feelings of fluency, familiarity, and positivity. For instance, work in my lab has replicated the well-known mere exposure effect – that familiar stimuli are rated favorably – and has also shown that stimuli manipulated to be positive are seen as more familiar. Other work has focused on the cognitive and perceptual outcomes of social exclusion. For instance, my collaborators and I have shown that excluded people process social information more carefully and, at times, more accurately in a variety of domains, including face processing and person perception.
